### Module Description:

Acquiring the skills, expertise and experience you need to be a practicing artist or designer is key to your future success. As well as the subject specific skills and experience you acquire, promoting yourself, seeking out and creating opportunities, working as part of a team, being adaptable, flexible and so on are all skills and attributes that contribute to achieving that goal. However, to secure or create employment for you, or to establish a professional practice, those skills also need to be augmented by the ability to engage in the reflective planning of your professional development goals in relation to your interests and practice.

*It is that planning and the presentation of your work that are the subject of this module.*

Although this aspect of your studies is delivered and assessed as a separate module, it is important to consider it as an integral part of your development as a creative practitioner. Many of the skills and attributes required for employability and professional practice that are mentioned above are in fact transferable skills that are regularly employed as you pursue and develop your studio work, and this module is intended to help you develop, adapt and apply those skills as you prepare for graduation and your place in the wider world. They should be equally valuable whether you intend to apply your creativity and ideas to a for-profit creative enterprise or for broader community, social or environmental purposes.

You will be required to carry out in-depth contextual research based on personal and professional interests in order to develop and consider different ways in which you can pursue your career aims. This may typically involve creating an online presence via blogs and social media, establishing a relationship with a professional mentor as part of planning for your future practice and employment, or exploring how you can develop ideas, opportunities and networks in order to be a successful creative professional.
