5. Brief Description of Module (purpose, principal aims and objectives)

The United Kingdom style of policing is well known, highly respected around the globe and as such the UK has regularly taken a leading role internationally, in supporting and developing effective and accountable policing practices.

Often this has been high profile, where serving and retired police officers have been involved in countries such as Afghanistan, Sierra Leone and Kosovo, where these highly skilled officers have played a part in helping a country get back on its feet following periods of war and instability.

Accountability of the police has always been the cornerstone of ethical police practice. The police should be accountable for their actions and to the community in which they serve. Accountability earns trust, confidence and cooperation and this ethos can be transferred through training and development overseas.

In this module students will research and learn about this international consultative policing process and critically analyse why this is seen as important to our own national security. How officers adjust to the complex nature of cultural difference, and how success or failure impacts on the wider context of stabilisation and a new world order.
