INTERNATIONAL FEE PAYMENT AND REFUND POLICY 2020/21

Information in this policy applies to students who will be applying to study at Colchester Institute and hold or will apply to enter the UK on a Tier 4 general student visa or short term study visa under the UK Home Office Tier 4 Points Based System. The payment methods have been set in accordance with our duties as Highly Trusted Sponsors and are non-negotiable. International students who do not require a visa to study at Colchester Institute must read the Further Education Fee Policy 2020/21 or the Higher Education Fee Policy 2020/21

Full-time Overseas fees 2020/21

English as Foreign Language (EFL) £2050- £4100

(E.g. Bachelor degree courses and above)

Included in the tuition fees:

- Issuing Confirmation of Acceptance for Studies number (CAS) to use for your visa application.
- Or
- Confirmation offer letter for a short term study visa
- Award body fees where collected by Colchester Institute
- Career guidance during and immediately following your course of study to provide advice on further studies and finding part-time work during your studies
- Confirmation letters to support opening bank accounts in the UK
- Use of fitness gym
- Use of Library and IT facilities.
- Course books for English Language courses
(There may be a small charge for books in other course areas)

Support for Dyslexia

Students requesting an assessment for dyslexia will be interviewed first and then offered a short assessment which will cost the student approximately £300.

If a student arrives with a diagnosis of dyslexia carried out in their home country and provides evidence no further assessment is necessary. In the event that a student is confirmed as having dyslexia, reasonable adjustments will be put in place, such as extra time for exams and use of extra cover sheets with assignments. Advance payment of Tuition Fees

Students made an 'Unconditional Offer' will be required to pay full fees in advance to confirm their place on the course, they will also be required to provide evidence of their bank statements showing the minimum funds to meet the financial requirements for the Tier 4 general student visa before a CAS certificate is issued.

Further Education tuition fee payment is £5750

Higher Education tuition fee payment is £8250

English Language courses, all fees must be paid in full before documents are issued to support visa applications.

Preventing Hardship

To prevent financial hardship students must not travel to the UK, or begin a course of study, without making sure that they have enough money to cover all tuition fees and living expenses for the duration of their programme. The Further Education and International Team at Colchester Institute will need to see evidence of your bank statements to confirm you meet the financial requirements for the Tier 4 general student visa before a CAS is issued.

Under the UK Home Office Tier 4 Points Based System policy guidance all Tier 4 General Students studying outside of London must show the following financial evidence when applying for their visa:

When providing evidence of finances to either the British Embassy in the student's home country or in the UK, you can use money held in an account owned by you or by your parent(s) or legal guardian(s). You will need to show evidence that you are related to your parent(s)/Legal Guardian(s) and that you have permission to use the money. Please check the guidance policy at, https://assets.publishing.service.gov.uk/government/uploads/system/uploads/attachment_data/file/812143/T4_Migrant_Guidance_JUNE_2019_FINAL_v3.pdf for clarification on the evidence required when using your parent/guardian accounts. (Tier 4 Policy guidance P32: 109.) The required money has to be held in the bank account consecutively for 28 days and the bank statement is dated maximum 28 days and ending no more than 31 days before your application.

The above guide on financing your studies is the minimum requirement for making your Tier 4 general student visa application. The guide below is an estimate of the amount you will need to fund the complete course you have chosen, the exact cost will depend on your individual circumstances and your lifestyle. Refunds

In cases of proven visa refusal – for example on production of a visa refusal letter from the UK Home Office – you can apply for a refund of your tuition fees. Other applications for refunds will be considered individually and will only be accepted in exceptional circumstances. **All refunds must be requested within 1 month from the start date of the course, any refunds requested after this time will not be accepted.**

An administration charge of £250 will be retained to cover administration costs for all overseas fee paying students.

Refunds will be made directly to the bank account of the individual who made the initial tuition fee payment.
