5. Brief Description of Module (purpose, principal aims and objectives)

This module supports the conceptualisation and realisation of a **self-directed music related project**, demonstrating independent study and research appropriate to level 6. Students will instigate their projects by submitting a proposal supported by initial findings; the proposal will be appropriate in scope, setting out realistic time-bound planning for the subsequent research activity. In order to investigate their subject area, students may choose a traditional approach to qualitative research or may prefer to adopt a practice-based methodology. To facilitate flexibility in assessment and personal learning preferences, students may also choose to present their reports in written, electronic or audio/visual formats, or in a combination of these. Practise-based outputs can include creative musical work.
